CASA D'ÓBIDOS undertakes to guarantee the confidentiality and privacy in the collection and processing of the data of its Clients and Users, fulfilling its obligations under the General Regulation on Data Protection, having for that purpose developed this Policy Privacy Policy.

General scope:

CASA D'ÓBIDOS is responsible for this Privacy Policy. The present covers this website, as well as other sites, microsites, forms and documents that mention the said policy.

Within the scope of this Privacy Policy, CASA D'ÓBIDOS defined as:

Customer: any entity that purchases our products; and

the User: any visitor to this website, as well as other sites and microsites that mention said policy and / or subscribers of our list of electronic content (Newsletter).

CASA D'ÓBIDOS reserves the right to update or modify its Privacy Policy at any time, in particular, in order to adapt it to legislative changes. The user is thus advised to visit this page regularly.

Consent:

By using this website, you are giving your consent for the collection and use of the information.

CASA D'ÓBIDOS may at any time modify, add or delete any of the privacy policies of its website (<https://www.casadobidos.com>) by updating the contents of this page.

Data collected:

CASA D'ÓBIDOS collects data from its Customers and Users, by submitting existing forms for this purpose, in digital and / or physical format.

CASA D'ÓBIDOS is the entity responsible for collecting and processing this data, deciding the categories of data collected, what its treatment is and the purposes it will provide.

All procedures performed in an automated and non-automated way that allow the collection, organization, storage, modification and transfer of personal data will be considered as "processing of personal data".

Use of data:

The data collected by CASA D'ÓBIDOS are intended for the communication process with Clients and Users, processing of requests for information, statistical analysis, as well as their use for the purposes of direct marketing.

CASA D'ÓBIDOS may use your personal data to send you any junk mail related to products or commercial offers that may be of interest to you. CASA D'ÓBIDOS does not sell or trade your data.

The user expressly authorizes CASA D'ÓBIDOS to send information about products and services that may be of interest to them using their personal data for the purpose of direct marketing through any communication channel, namely through the use of electronic mail, telephone, SMS , MMS, or other forms of automatic calling. CASA D'ÓBIDOS will not market or share its customer database with third parties.

Access to data:

CASA D'ÓBIDOS does not disclose to third parties any personal data of its Customers and Users, without their consent, except (1) when dealing with Group companies, or (2) when it is necessary for employees, employees, suppliers or business partners of CASA D'ÓBIDOS may provide a product or service or perform a function on behalf of CASA D'ÓBIDOS, or (3) where required or permitted by law.

CASA D'ÓBIDOS shall take reasonable precautions to ensure that its employees or employees with access to personal data are adequately trained in their correct processing, with respect to this policy and legal data protection obligations. In case of non-compliance, CASA D'ÓBIDOS will apply disciplinary sanctions to its employees and employees.

Whenever CASA D'ÓBIDOS discloses the personal data of the user will safeguard compliance with the Law of Protection of Personal Data, namely through the provision of contractual

provisions that ensure that the third party uses the data received only for the purposes specified, and in accordance with the purposes described in this policy, and that it makes use of appropriate means of security, in order to protect the personal data of the user against illegal or unauthorized treatments as well as against their accidental loss, destruction or other harmful actions.

Data storage:

CASA D'ÓBIDOS keeps the data of its customers and Users on its servers located in Portugal. These servers are protected and maintained in accordance with high standards of security and in order to comply with the applicable privacy laws.

Data Storage Time:

The period of time for the storage and preservation of the personal data of Customers and Users of CASA D'ÓBIDOS varies according to the purpose.

The personal data of the Users of our website and microsites will be preserved until they remain active and are deleted for the purpose of this use.

The personal data provided for our mailing list distribution will be stored until the end of its use. In this case, Customers and Users may cancel, at any time, the subscription of the alerts through the option of cancellation provided in the Newsletters.

Customer data and other specific data to be kept to comply with CASA D'ÓBIDOS 'legal obligations may be extended for a maximum period of up to 10 years (in accordance with article 130 of the Corporate Income Tax Code) , at the end of which they will be eliminated.

Data security:

CASA D'ÓBIDOS has taken the necessary technical and organizational measures to adequately protect its data regarding unauthorized processing and access.

CASA D'ÓBIDOS makes every reasonable effort to prevent the unauthorized or illegal use of the user's personal data, as well as its loss, destruction or damage. However, CASA D'ÓBIDOS can not provide an absolute guarantee regarding the data of the User. Whenever there is an escape, loss or violation of personal data that is likely to pose a high risk to the rights and freedoms of its Customers and Users, CASA D'ÓBIDOS will:

Notify, within 72 hours after being informed of the event, the control authorities;

Communicate the situation to the affected data owner (s) in a timely manner.

CASA D'ÓBIDOS guarantees the security of the personal data of the user through the following means: (1) use of encryption with certificate in all communications of the website, (2) use of password to access the website; and (3) limitation of access to personal data (for example, access only to employees or employees of CASA D'ÓBIDOS who need to access them for the purposes described above).
